*To all OPSEU members of a Regulated Health Profession*

Dear friends,

In December 2009, Bill 179 received Royal Assent making it law for all members of a Regulated Health Profession to carry Professional Liability Insurance (PLI). This law will be fully implemented by 2012.

We are pleased to announce that the OPSEU Hospital Professional Division Executive has, in consultation with CG&B Insurance Group, arranged for members of Regulated Health Professions to get PLI at a discounted rate. For \$40 per year, you can receive PLI that meets all the requirements of Bill 179.

This same insurance can also be obtained through an association, but it may be at a higher rate and you will also have to factor in your association fees.

The insurance available through CG&B is not only applicable to members of the Hospital Professionals Division, but for every OPSEU member who is also a member of a Regulated Health Profession.
